- 6+ years' relevant work experience on privacy / GDPR
- Experience in leading teams and projects

Minimum salary: € 80.000\* gross (about € 49.300 net)

\* Austrian law requires to post a minimum salary (per 40h/week). Considerably higher amounts are possible, depending on qualifications .
