#### **TERMS OF REFERENCE**

ICLEI Africa is working with the Deutsche Gesellschaft für Internationale Zusammenarbeit (GIZ) on the Covenant of Mayors in Sub Saharan Africa (CoM SSA) initiative co-funded by the European Union (EU), the Federal Ministry of Economic Cooperation and Development of Germany (BMZ), and the Spanish Agency for International Development Cooperation. Started in 2015, CoM SSA is the African regional chapter of the Global Covenant of Mayors (GCoM), the largest network of cities driving urban climate action. CoM SSA empowers its network of over 230 African cities to take concrete actions in overcoming the effects of climate change and increasing access to sustainable energy.

This Terms of Reference (ToR) relates to supporting ICLEI Africa with advice on mainstreaming gender into our work within the CoM SSA initiative.

#### 1. BACKGROUND

Climate change impacts men and women differently. As part of ICLEI Africa's work under CoM SSA, we strive to mainstream gender by considering both gender equality and women's empowerment as important factors in low carbon and resilient development. As signatories to CoM SSA, cities commit to develop, implement and monitor a Sustainable Energy Access and Climate Action Plan (SEACAP), which is both an operational and a political document that covers three pillars: climate change mitigation, climate change adaptation and access to energy. Gender considerations are currently not mandatory in the development of a SEACAP nor in associated tools and resources. To assist cities in bridging this gap, we would like to provide support and concrete tools to African cities for the development of gender-sensitive SEACAPs. This would entail recommendations and tools to ensure an inclusive development and implementation process of a gender-responsive SEACAP, including: i) gender-sensitive data collection; ii) equitable participation and influence of women and men in decision-making; and iii) gender-sensitive design and implementation of energy and climate actions.

GIZ and ICLEI Africa are currently supporting four cities in the development of their SEACAPs. The process is highly participative and involves government officials, representatives from different sectors, CSOs/NGOs, civil society and traditional authorities. In partnership with the cities, on-the-ground service providers, GIZ and ICLEI Africa are responsible for:

- Designing and managing the data collection process for the climate change adaptation, climate change mitigation and energy access pillars of the SEACAP;
- Analysing the data and writing a baseline analysis report, a target setting report and an action planning report for each of the three pillars within the SEACAP (adaptation, mitigation and access to energy); and
- Conducting training workshops for municipal officials and other stakeholders on data collection and other related SEACAP concepts and processes.











In addition to this targeted support to the four cities, GIZ and ICLEI Africa are developing training/support products on SEACAP development which will benefit all CoM SSA cities. This includes a SEACAP Toolbox which aims to guide CoM SSA cities along each step of their SEACAP development.

#### 2. OBJECTIVES

The objective of this Terms of Reference (ToR) is for a consultant to support ICLEI Africa and GIZ to mainstream and embed gender considerations in several activities under CoM SSA. Specifically, the gender consultant will be expected to provide suggestions, recommendations and real world examples to include in the SEACAP toolbox to make it more gender inclusive and gender conscious; and develop case studies successfully showcasing how gender has been considered in climate change adaptation, mitigation and/ or energy projects in Africa.

#### 3. ROLE OF THE GENDER EXPERT

### 3.1 Inception Meeting

The service provider is expected to take part in a brief inception meeting with the ICLEI Africa team to discuss the assignment. The inception meeting will take the form of a short online meeting via Zoom or a similar platform. During the course of the inception meeting, ICLEI Africa and the service provider will discuss and confirm the requirements and scope of works for this assignment. The service provider will also be offered the opportunity to ask any questions before commencing with the assignment.

## 3.2 Provide inputs on the SEACAP Toolbox

Version 1 of the SEACAP Toolbox was developed in 2020 and takes the form of four modules presented as an easy to use pack of PowerPoint slides of approximately 600 slides in total. Version 2 of the SEACAP Toolbox is currently being developed and this will include two additional modules which should also be assessed as part of this piece of work (estimated to be a maximum of 700 slides in total). The work under this deliverable will entail:

- (1) holding a half-day meeting with the GIZ and ICLEI Africa team to go through the SEACAP Toolbox to discuss what it includes and how GIZ and ICLEI Africa and member cities use it; as well as the expectations of this component of this piece of work
- (2) Reviewing Version 2 of the SEACAP toolbox in detail and providing concrete suggestions, recommendations, tools, methodologies, relevant examples and edits that should be incorporated into the SEACAP Toolbox to ensure that gender considerations are embedded throughout and support the development of genderresponsive SEACAPs

**Deliverable 3:** Reviewed version of Version 2 of the SEACAP Toolbox which includes suggestions, recommendations, tools, methodologies, relevant examples and edits that should be incorporated into the SEACAP Toolbox.

3.2 Compile 6 best practice case studies on gender mainstreaming initiatives, programmes and projects in Sub-Saharan Africa related to climate change and energy access

The gender expert will be expected to compile 6 case studies which successfully showcase how gender can/has been considered in climate change adaptation, mitigation and/ or energy projects in Africa. There should be a minimum of two case studies per pillar (adaptation, mitigation and energy access), with each case study covering a different sector (e.g. agriculture, transport, health, etc). To complement the many existing case studies on



successful gender mainstreaming in climate and energy initiatives, this assignment should consider:

- Examples of actions led by Sub-Saharan African local governments;
- Examples of actions financed directly (municipal budgeting) by local governments;
- Innovative adaptation, mitigation and energy access initiatives;
- Innovative ways of mainstreaming gender; and
- A good sub-geographical balance of examples (i.e. not only Southern or Eastern African examples).

Each case study should include, but not be limited to:

- Details on the initiative (project holder, implementation dates, location, funders, stakeholder involved, scope of the initiative, number of beneficiaries, expected impact);
- Key challenges and lessons learned on the gender mainstreaming aspect of the initiative;
   and
- Sources of information and relevant links to read more about the initiative.

### **Key Deliverables:**

**Deliverable 4:** 6 case studies which successfully showcase how gender can/has been considered in climate change adaptation, mitigation and/ or energy projects in Africa.

### 4. ROLE OF THE PROJECT PARTNERS

The project partners (ICLEI Africa and GIZ) will support the gender expert to ensure the successful delivery of the work by:

- Providing all existing gender related material developed as part of the CoM SSA initiative for the consultant's review and to build upon; and
- Providing requirements and specifications for the development of new knowledge products.

### 6. SERVICE PROVIDER REQUIREMENTS

Proposals may be submitted by an individual or a team of individuals (as a consortium) and must meet the following requirements:

- Bachelor's or Postgraduate degree in gender studies or similar. Additional qualifications in the fields of development studies, international development, climate change, energy will be an added advantage;
- In accordance with EU funded projects, a minimum of five (5) years gender mainstreaming professional experience including gender training experience;
- Demonstrate expertise, experience (minimum 3-years) and knowledge and understanding of access to energy, climate change mitigation and adaptation;
- Demonstrated experience in contributing to the design of climate change projects (such as the development of a Gender Action Plan for a GCF Funding Proposal) is an added value:
- Experience with mainstreaming gender into climate change and energy sectors is essential:
- Experience working in Africa countries and/or with cities in Africa;
- Fluency in English. A working knowledge of French will be an added advantage but not considered essential;
- Proven experience developing technical reports and training material on gender mainstreaming, climate change and energy access; and
- Excellent workshop facilitation skills.

### 7. EVALUATION CRITERIA

Bids will be evaluated against the following criteria:

- Demonstrated Skills and Expertise, linked to those indicated in this ToR;
- Demonstration of Experience;
- Interpretation of the Terms of Reference; and Price (per portion of work indicated above), including Hourly/Daily rates and number of Hours/Days per portion of work;

Payment will be made post completion of each portion of work as indicated in this ToR in accordance with the satisfactory and timeous delivery of services and upon receipt of fully compliant invoices.

- 5) A B-BBEE certificate (if applicable); and
- 6) A risk matrix and mitigation measures.
